Waiver and Authorization for Medical Attention: I, the undersigned, as participant or as parent or guardian of the participant, hereby recognize and acknowledge that recreation activities may involve bodily and/or emotional injury to myself and/or the participant and that Sunset City does not carry special health or accident insurance that would protect the participant in the event of accidental injury while participating in any program or facility offered by Sunset City. Any accident or injury shall be referred to my insurance carrier and I assume full responsibility for the same. I agree to personally assume all expenses associated with accidents or injury arising out of participating in activities offered by Sunset City. I hereby voluntarily and knowingly release and discharge Sunset City, its governing offices, Employees, staff or agents from all obligations, liabilities, claims, demands, costs and expenses,

including attorney fees, arising out of or in connection with any injury sustained by the participant. I hereby authorize Sunset City, its employees or agents, to act on my behalf in accordance with their best judgment in case of an emergency. I authorize Sunset City, its employees or agents, to notify emergency help in case of an accident or injury sustained by their participation in programs offered by Sunset City.

"Code of Conduct": I will encourage good sportsmanship by demonstrating positive support for all players, coaches, leaders and officials at every recreation event. I will refrain from the use of foul language and/or negative comments toward players, coaches, leader, officials or spectators. I will provide support for coaches and officials working in the programs or events. I will refrain from using drugs, alcohol and tobacco at all Sunset City events. I will abide by all rules and standards regarding situations the participant is involved in.

Refund Policy: The Recreation Department will withhold \$10.00 of the registration fee for administrative costs. No refunds will be allowed after programs or classes have started, regardless of the participant's non-attendance, except for unforeseeable circumstances and these will be handled on a case by case basis by the Recreation Department. Refund checks will be sent via mail within then (10) business days of the withdrawal from the program.
