- A) Registered voter of Sunset City at the time of filing; and
- B) Resident of Sunset City by living in Sunset City for the 12 consecutive months immediately before the date of the election.

In accordance with Utah Constitution Article IV, Section 6, any mentally incompetent person, any person convicted of a felony, or any person convicted of treason or a crime against the elective franchise may not hold office in this state until the right to hold elective office is restored under Section 20A-2-101.3 or 20A-2-101.5.

Am I agree to file all campaign financial disclosure reports, and I understand that failure to do so may result in my disqualification as a candidate for this office and removal of my name from the ballot as well as other penalties in accordance with Sunset City Ordinance.
